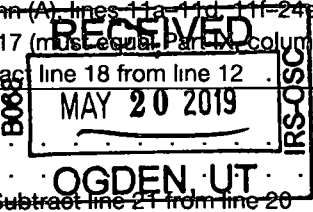

To provide Human trafficking education and awareness presentations to a variety of audiences which include lawyers, legislators, medical providers, law enforcement, participation in Statehouse annual Human Trafficking Day events and symposiums, participating in various public forums with stakeholder organizations, survivors of human trafficking, service providers, state and local governmental agencies, schools, colleges, prisons and the general public

Project Red Cord: Renee Jones Empowerment Center (RJEC) provides continuing care programs and services to human trafficking victims, survivors and those vulnerable to being trafficked. RJEC staff and volunteers provide free programs and services that include: life skills; coaching; benefit identification; counseling; support groups; journal writing; art therapy; equine therapy; mentoring; self-esteem workshops; and, prostitute anonymous meetings. In October 2018, the NEO human trafficking law clinic's legal services were added to RJEC which provides legal assistance that can include expungements, addressing credit issues, child custody issues and a variety of other legal issues that a victim can face on their road to regaining their life back. RJEC also provides a court advocacy service by attending court hearings with adult and juvenile clients to support victims and their families. Also, the advocate informs the families of the continuing care programs and services offered at RJEC. The court advocate visits clients if they are sent to jail or treatment centers to maintain support until they are able to come to the center and receive services.
