Project Red Cord is a wholly unique program in the state of Ohio and throughout the United States. It is a model of well-integrated and combined services to provide human-trafficking survivors with holistic healing and restoration while providing the opportunity for life-changing empowerment for those who have been victimized by human trafficking. It differs from all other projects in that it provides survivors with an intense array of innovative trauma informed programs, services, treatments and (continued on Schedule O)

Community Awareness, Public Engagement, Advocacy to advocate for legislative reform so state and federal laws assist human trafficking victims, penalize traffickers, and reduce the demand for sexual exploitation. Project Red Cord also offers a wide range of innovative human trafficking education, prevention and awareness programs that include two conferences, community awareness events, a traveling human trafficking exhibition, a powerful photo exhibit depicting the stories of human trafficking and sexual assault survivors and the triggers that haunt them. These presentations are made to a variety of audiences which include lawyers, legislators, medical providers, law enforcement, participation in Statehouse annual Human Trafficking day events and symposiums, participating in various public forums with stakeholder organizations, survivors of human trafficking, service providers, state and local government agencies, schools, colleges, prisons and the general public.

4b (Code 624100) (Expenses \$ 26,004 including grants of \$ 24,907) (Revenue \$ 0)
Project Red Cord RJEC provides continuing care programs and services to human trafficking victims, survivors and those vulnerable to being trafficked. RJEC staff and volunteers provide free programs and services that include Life skills, coaching, benefit identification, counseling, group therapy, support groups, journal writing, art therapy, equine therapy, mentoring, self-esteem workshops, and prostitutes anonymous. RJEC also provides a court advocacy service by attending court hearings with adult and juvenile clients to support victims and their families and also the advocate informs the families of the continuing care program and services offered at RJEC. The court advocate also visits clients if they are sent to jail or treatment centers to maintain the support until they are able to come to the center to receive services. Project Red Cord also offers a unique street outreach program called Project Red Cord Night Out to reach marginalized and underserved populations in communities and locations that are known for high levels of prostitution, poverty, drug overdose.
