Where a conflict of interest is determined to exist, the person with the conflict shall be prohibited from participating in deliberations and decisions regarding the proposed contract, transaction or arrangement. The YMCA shall not enter into the proposed contract, transaction or arrangement unless the board has complied with the following (1) the chairperson of the board shall if appropriate appoint a disinterested person or committee to investigate alternatives to the proposed contract, transaction or arrangement (2) after exercising due diligence the board shall determine whether the Y can with reasonable efforts get a more advantageous contract, transaction or arrangement from a person or entity without a conflict of interest (3) if a more advantageous transaction or arrangement is not reasonably possible the board shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Y's best interest for its benefit and whether it is fair and reasonable, in conformity with the above determination the board shall make its decisions as to whether to enter into the contract, transaction or arrangement.</p>
