ALL OTHER WORK IS PERFORMED BY VOLUNTEERS WHO PROVIDE FREE GROCERIES AND PERSONAL ITEMS (TOILET TISSUE, SOAP, DEODORANT, TOOTH PASTE, TOOTHBRUSHES, LAYETTES AND DIAPERS) TO APPROXIMATELY 2,000 FAMILIES EACH MONTH.
