The Wabash County YMCA strives to enrich lives and strengthen the community. In 2015, the Wabash County YMCA was able to nurture the potential of children and teens, improve our community's health and well-being, and provide support to our neighbors through new initiatives and growing programs. The engagement and generosity of residents enable the Y to address our county's most pressing needs and overcome barriers by focusing on three key areas: youth development, healthy living, and social responsibility.

**YOUTH DEVELOPMENT** Our YMCA is committed to nurturing the potential of every child and teen. We believe that all kids deserve the opportunity to discover who they are and what they can achieve. That's why we help young people cultivate the values, skills and relationships that lead to positive behaviors, better health and education achievement. Our YMCA youth development programs, such as Summer Learning Loss Prevention program, offer a range of experiences and enrich cognitive, social, physical, and emotional growth. Expenses include subsidies and direct financial assistance that make participation possible for 34% of young people we engage. Summer Learning Loss Prevention: The Wabash County YMCA operated a summer learning loss prevention program servicing 148 students who entered first, second and third grades. The Summer Program of Awesome Reading Kids (SPARK) is operated in collaboration with the Metropolitan School District (MSD) of Wabash County, Manchester Community Schools, and Wabash City Schools. SPARK provided literacy instruction from certified teachers to ensure that students in the program did not experience summer learning loss, and in fact most students even gained reading skills and many can begin this coming school year at grade level. Students gained an average of two and a half months of reading ability over the course of the six-week program. Students also experienced many enriching activities such as art, music, physical activity, character development, and field trips. Wabash County Promise/Promise Indiana: In past years, the YMCA collaborated with other community leaders to develop and launch an initiative called the Wabash County Promise. The Promise affords an actionable means for the county to build assets for our youth - by influencing expectations, changing behaviors, fostering excitement and hope for the future and developing 529 college savings accounts. The Promise has proven to be a highly effective initiative for uniting our families and schools in a common vision of greater prosperity and hopefulness. The Promise puts intentional systems in place so families can become their own solution. At the school events, teachers and school staff can reinforce the message that every child has a bright future and families should be looking forward to the day when their elementary student will head off to college. The Promise removes some of the biggest barriers for families - lack of time, lack of access to a reliable internet connection or a computer, and simply putting savings at the bottom of a long list of things to do to help their child be successful. The Promise helps increase awareness of 529 accounts and, more importantly, the benefits of families taking action to save. To date, The Promise has resulted in over \$1,000,000 in deposits into CollegeChoice 529 college savings accounts. Through a deep partnership with Indiana's CollegeChoice529 program, as of 2016, The Promise is now engaging students from 43 school districts, 105 schools, and 886 classrooms throughout the state of Indiana. Youth Sports: A youth sports experience has the power to positively influence the development of a child. In our community, there are kids who are not participating because of minimal parental involvement or financial hardship. The youth sports initiative assigns youth sport scholarships to each elementary school and leaders of other community agencies. These partners help identify youth or teens and get them in the game. In 2015, 5,331 youth participated in sport experiences through the Y. The combination of caring adults, skills development, and first class environment produces measurable increases in a child's well-being. One participant, Bo, has a disabled, single father. Bo participates in flag football and soccer, and despite having cerebral palsy was able to be his team's goalie in 2015. To hear Bo talk about sports, you would never know that he has barriers to competing.

**HEALTHY LIVING** The Y is the leading voice on health and well-being in Wabash County. We bring families closer together, encourage good health, and foster connections through fitness, sports, fun, and shared interests. As a result, over 12,000 people in our community are receiving the support, guidance, and resources they need to achieve greater health in spirit, mind and body. This is particularly important as our nation struggles with an obesity crisis, families struggle with work/life balance, and individuals search for personal fulfillment. Our programs are accessible, affordable, and open to all faiths, backgrounds, abilities, and income levels. In 2015, we provided financial assistance and subsidy to 4,115 people who otherwise may not have been able to afford to participate. The Y also plays a lead role in improving community health through Be Well Wabash County. Be Well Wabash County brings together collaborative leaders to strategically address the health issues within the community. Health and Well-being: One out of every three residents of Wabash County participates in Y programs designed help them reach their wellness goals. Participants receive assistance in developing a training program, support and accountability. All members have access to resources to strengthen faith, mental health and financial well-being. Special events like the Dash in the 'Bash is a 5K run brings our community together to celebrate fitness goals and have fun being active. By seeking to reach every member where they are, we are able to support varied goals, skill levels and needs. Water Safety Program: In partnership with local schools and Parkview Hospital, the Y conducts a life lessons swim program. In 2015, 627 fourth and fifth grade students in Wabash City Schools and MSD of Wabash County participated in the program at no cost. Students developed confidence in the water, improved swim skills, and learned life lessons through water safety awareness.

**SOCIAL RESPONSIBILITY** The YMCA believes in giving back and supporting our neighbors. In Wabash County, we have been listening and responding to our community's most critical social needs for more than 13 years. Y programs, such as financial literacy education, are examples of how we deliver training, resources, and support that empower our neighbors to effect change, bridge gaps, and overcome obstacles. In 2015, we engaged 12,142 YMCA members, participants, and volunteers in activities that strengthened our community and paved the way for future generations to thrive. Togetherhood: In late summer 2015, over 300 dedicated Wabash volunteers come together for Togetherhood, a day supporting the needs of over 20 local nonprofits. The Y mobilizes our members and community to serve! Many local nonprofits have trouble taking care of small maintenance projects around their offices because of the hard and important work they do in our community every day. Togetherhood allows us to provide encouragement to the work of our other local nonprofits and volunteers. After volunteers finished a bit of painting and cleaning at the ACCESS, a local after-school youth club, they asked the director if there was anything else they could do. The director joked that they needed the upstairs wired for lights. The volunteers left, went to get supplies, and came back to wire the upstairs. The ACCESS now has lights in their second floor! Financial Literacy: One in three members of the Wabash County YMCA receives financial assistance. All families who qualify for financial assistance are able to receive Christ-centered financial literacy education so they can build the knowledge and skills to help themselves break the grip of financial distress. Over three months, on average participants experiences a significant improvement in their financial position and 22% improvement in financial well-being.





