The mission of the Wabash County YMCA is to put Christian principles into practice through programs that build healthy spirit, mind and body, for all. In 2016, the Wabash County YMCA was able to nurture the potential of children and teens, improve our community's health and well-being, and provide support to our neighbors through new initiatives and dynamic programming. YOUTH DEVELOPMENT The Y is committed to nurturing the potential of every child and teen. We believe that all kids deserve the opportunity to discover who they are and what they can achieve. That's why we help young people cultivate values, skills and relationships that lead to positive behaviors, better health and education achievement. YMCA youth development programs specifically target at-risk youth using best-practices methods. As a county where 1 in 2 children under 18 are living near the poverty line, this is key. Summer Learning Loss Prevention During the summer of 2016, the Y operated a summer learning loss prevention program for 148 students who entered first, second and third grade in Fall of 2016. 100% of participants in 2016 qualified for free and reduced lunch, putting them at higher risk for summer learning loss. SPARK provided literacy instruction from certified teachers to ensure that students in the program did not experience summer learning loss, and in fact most students even gained reading skills and many began the next school year at grade level. Students also experienced many enriching activities such as art, music, physical activity, character development, STEM enrichment, and field trips. Wabash County Promise/Promise Indiana In past years, the YMCA collaborated with other community leaders to develop and launch an initiative called the Wabash County Promise. The Promise affords an actionable means for the county to build assets for our youth - by influencing expectations, changing behaviors, and developing 529 college savings accounts. To date, the promise has resulted in over \$3,500,000 in deposits into Collegechoice 529 college savings accounts. Through a deep partnership with Indiana's Collegechoice529 program, as of 2016, promise is now engaging students from 43 school districts, 105 schools, and 886 classrooms throughout the state of Indiana. Youth Sports A youth sports experience has the power to positively influence the development of a child. In our community, there are kids who are not participating because of minimal parental involvement or financial hardship. The youth sports initiative assigns youth sport scholarships to each elementary school and leaders of other community agencies. These partners help identify youth or teens and get them in the game. In 2016, approximately 2,500 youth participated in sport experiences through the Y. HEALTHY LIVING The Y is the leading voice on health and well-being in Wabash County. We bring families closer together, encourage good health, and foster connections through fitness, sports, fun, and shared interests. As a result, over 12,000 people in our community are receiving the support, guidance, and resources they need to achieve greater health in spirit, mind and body. This is particularly important as our nation struggles with an obesity crisis, families struggle with work/life balance, and individuals search for personal fulfillment. In 2016, 1 in 4 members who otherwise wouldn't have been able to participate, received that opportunity through financial assistance. Health and Well-being One out of every three residents in our primary market area is a member of the Y and countless visitors participate in Y programming to improve well-being. All members have access to RightNow Media, which lets health seekers listen to devotionals and Bible studies while they work out - providing wellness for mind, body, and spirit simultaneously. Group exercise classes for all abilities and interests happen every day of the week, at all hours of the day, and Dash in the 'Bash is a 5K run that brings our community together to celebrate fitness goals and have fun being active. By seeking to reach every member where they are, we are able to support varied goals, skill levels and needs. SOCIAL RESPONSIBILITY The YMCA believes in giving back and supporting our neighbors. In Wabash County, we have been listening and responding to our community's most critical social needs for more than 13 years. Y programs, such as Togetherhood, are examples of how we deliver training, resources, and support that empower our neighbors to effect change, bridge gaps, and overcome obstacles. In 2016, we engaged volunteers in 9,876 hours of work that strengthened our community and paved the way for future generations to thrive. 12,760 free meals were served to children in need. Togetherhood In late summer 2016, over 200 dedicated Wabash volunteers come together for Togetherhood, a day supporting the needs of over 15 local nonprofits. The Y mobilizes our members and community to serve! Many local nonprofits have trouble taking care of small maintenance projects around their offices because of the hard and important work they do in our community every day. Togetherhood allows us to provide encouragement to the work of our other local nonprofits and volunteers. Water Safety Program In partnership with local schools and Parkview Hospital, the Y conducts a water safety swim program. In 2016, 567 kids in kindergarten through seventh grade participated in the program at no cost. Students developed confidence in the water, improved swim skills, and learned life lessons through water safety awareness.
