The length of stay of the children in the foster homes is dependent upon the treatment needs of the children.

Community-Based Services Community-Based Services attempts to provide necessary services, which enable families to achieve permanence or assist in reunifying children with their parents. Youths are referred to this program by county juvenile courts and local offices of the Department of Children Services throughout Indiana.

Father Engagement Services The Organization provides Father Engagement Services to fathers through referral from the Department of Child Services. The goal of the Father Engagement Services is to improve the overall well-being of families and communities served through strengthening the presence and understanding the importance and skill sets of its fathers. Whites utilizes evidenced-based treatment modalities including Motivational Interviewing and Nurturing Parenting.
