The high quality curriculum mitigates the risks to development and promotes school readiness to help the children reach their potential and be successful in school and later life. It is expected that poor children enter kindergarten at a 3 or 4 year development level. 83% of our children leaving for kindergarten were functioning at a 5 year old level in all developmental domains. Children are considered proficient if they are proficient in 80% of items within the category.
