We serve more than 1,100 at-risk youth each year, reaching an average of 500 children daily with over 1,400 members. In St. Joseph County, 19% of our children live at or below the state poverty level. 72% of our Club members come from single parent homes, and 9% of our Club members that attend our flagship O.C. Carmichael Jr. Youth Center (O.C.) are homeless. Although our annual programming costs are well over \$1,000 per member, we understand that the population we are serving is under the poverty line and offer our program at a cost of \$50 per member for the entire school year. No child is turned away because of an inability to pay, and nearly 40% of all memberships are entirely subsidized through a blended funding strategy.
