HOW WE HELP OFTEN, BRINGING TOGETHER CORPORATE AND MINORITY BUSINESSES IS SIMPLY A COMMUNICATION ISSUE. MEMBERSHIP IN THE COUNCIL HELPS TO SOLVE THAT PROBLEM BY PROVIDING THE VEHICLE FOR EFFECTIVE NETWORKING AND COMMUNICATION. MANY ACTIVITIES AND PROGRAMS OF THE COUNCIL ARE DESIGNED TO BRING BUYERS AND SELLERS TOGETHER TO DISCUSS BUSINESS PROBLEMS AND SHARE KNOWLEDGE. BELONGING TO THE MID-STATES MSDC IS GOOD FOR BUSINESSES BECAUSE A SOUND MINORITY PURCHASING PROGRAM INCREASES THE QUALITY AND DEPTH OF AN ORGANIZATION'S SUPPLIER BASE.
