THE ASU ALSO REQUIRED EXPANDED DISCLOSURES RELATING TO THE NATURE, AMOUNT, TIMING, AND UNCERTAINTY OF REVENUE AND CASH FLOWS ARISING FROM CONTRACTS WITH CUSTOMERS. MSMSDC ADOPTED THE NEW STANDARD EFFECTIVE JANUARY 1, 2019, THE FIRST DAY OF MSMSDCS FISCAL YEAR USING THE MODIFIED RETROSPECTIVE APPROACH . THIS GUIDANCE WAS APPLIED TO ALL CONTRACTS NOT COMPLETED AT THE ADOPTION DATE. UPON ADOPTION OF ASC 606, MSMSDC RECORDED AN ADJUSTMENT TO RECOGNIZE A CONTRACT LIABILITY OF 130,773 RELATED TO MEMBERSHIP REVENUE AND CERTIFICATION FEE REVENUE THAT WERE PREVIOUSLY RECOGNIZED AS REVENUE AS BILLED; UPON ADOPTION OF ASC 606, MSMSDC IS RECOGNIZING THIS REVENUE OVER THE CONTRACT PERIOD. THE ADJUSTMENT OF 130,773 WAS RECORDED AS A REDUCTION TO NET ASSETS AS OF JANUARY 1, 2019, THE DATE OF ADOPTION OF ASC 606.</p>
