KARSS - KEEPING AT RISK STUDENTS IN SCHOOL (KARSS) IS A COOPERATIVE EFFORT BETWEEN THE JAY SCHOOL CORPORATION AND THE ORGANIZATION. THE PROGRAM WAS DESIGNED TO RETAIN SUSPENDED AND EXPELLED STUDENTS IN SCHOOL, AND REDUCE THE DROPOUT RATE FOR THESE AT-RISK STUDENTS. KARSS, (PRONOUNCED 'CARS') WORKS WITH THE STUDENT AND HIS/HER FAMILY AS APPLICABLE TO IDENTIFY BEHAVIORAL CONCERNS, ADDRESS ACADEMIC AND INDIVIDUAL INTERESTS OF THE STUDENT, AND PROVIDE OPPORTUNITIES TO DEVELOP A SENSE OF VOLUNTEERISM SO HE/SHE WILL CONTINUE A REGULAR SCHOOL ROUTINE, SUCCESSFULLY GRADUATE, AND HAVE OPPORTUNITIES FOR INDIVIDUAL GROWTH. THE OPPORTUNITIES IN THE COMMUNITY TO DEVELOP AN AWARENESS OF SERVICE TO OTHERS IS A STRONG COMPONENT PROVIDED THROUGH THE AGENCIES THAT ASSIST IN MENTORING THE YOUTH RECEIVING AND PARTICIPATING IN THIS PROGRAM. BORN TO LEARN - THE JAY COUNTY BORN TO LEARN PROGRAM IS A COLLABORATIVE VENTURE BETWEEN THE YOUTH SERVICE BUREAU OF JAY COUNTY, INC., PORTLAND FOUNDATION, PORTLAND ROTARY CLUB, AND UNITED WAY OF JAY COUNTY. THIS IS A CHILD ADVOCACY PROGRAM, AND WILL TARGET AN UNDERSERVED POPULATION OF PARENTS AND YOUNG CHILDREN IN JAY COUNTY. BORN TO LEARN PROVIDES PARENT CURRICULUM, ADDRESSES DEVELOPMENTAL MILESTONES, AND ASSISTS FAMILIES IN ACCESSING RESOURCES. COMMUNITY PARTNERS FOR CHILD SAFETY - WORKING IN PARTNERSHIP WITH CHILDREN'S BUREAU TO PROVIDE VOLUNTARY SERVICES TO REGION 7 (BLACKFORD, DELAWARE, GRANT, JAY AND RANDOLPH COUNTIES), THE YSB FOCUSES ON THOSE FAMILIES RESIDING IN BLACKFORD, JAY AND RANDOLPH. SERVICES PROVIDED INCLUDE: SERVICE COORDINATION, INFORMATION AND REFERRALS, IN-HOME CASE MANAGEMENT, AND ADVOCACY FOR THE FAMILY. THIS PROGRAM WAS DISCONTINUED FOR THE YEAR ENDING SEPTEMBER 30, 2018. TUTORING - TUTORING IS A PROGRAM AVAILABLE TO YOUTH WHO ARE STRUGGLING IN THE PUBLIC-SCHOOL SYSTEM. EDUCATION IS THE KEY COMPONENT, ALONG WITH PROVIDING STRUCTURE AND ROUTINE. STUDENTS ARE HELD ACCOUNTABLE FOR BEHAVIOR AND PROGRESS IN ACADEMICS. COMMUNITY BASED SERVICES - CHILDREN IN THE MIDDLE WAS ESTABLISHED THROUGH A REQUEST BY THE JAY COUNTY LEADERSHIP ACADEMY IN 1995. THIS PROGRAM IS AVAILABLE TO THOSE PARENTS GOING THROUGH A DIVORCE. LOCAL AND SURROUNDING SUPERIOR AND CIRCUIT COURTS REQUIRE DIVORCING PARENTS TO ATTEND THESE CLASSES. PARENTS ARE PROVIDED INFORMATION AND ARE ABLE TO DISCUSS WITH OTHER PARENTS THE FOLLOWING: WAYS TO MINIMIZE THE IMPACT OF DIVORCE ON THE CHILDREN, TEACHING PARENTS HOW TO AVOID THE COMMON PITFALLS ASSOCIATED WITH THE DIVORCE PROCESS, AND HOW TO EFFECTIVELY REASSURE THEIR CHILDREN AS THEY ADJUST TO THE CHANGES IN THEIR LIVES. BASE (BEHAVIORAL ACADEMIC AND SOCIAL EDUCATION) IS A JOINT VENTURE BETWEEN YOUTH SERVICE BUREAU OF JAY COUNTY, INC. AND GREATER RANDOLPH INTERLOCAL COOPERATIVE. THIS PROGRAM IS DESIGNED TO TARGET AT RISK STUDENTS. IT FOCUSES ON BEHAVIOR MODIFICATION WITH AN EDUCATION EMPHASIS, AND INCLUDES INDIVIDUAL COUNSELING, MENTORING, AND A FAMILY COMPONENT. THINKING FOR A CHANGE IS A PROGRAM DEVELOPED IN COOPERATION WITH COMMUNITY CORRECTIONS. THIS PROGRAM PROVIDES SERVICES TO ADULTS WHO HAVE BEEN REFERRED THROUGH THE COURTS, PROBATION, AND COMMUNITY CORRECTIONS. AS ASSESSMENT IS COMPLETED, AND THEN A CLASSROOM COMPRISING OF 8-12 INDIVIDUALS IS CONDUCTED FOR 2 HOURS PER SESSION, WITH A MINIMUM OF 17 CLASSES PER SESSION TO BE COMPLETED. THE SESSIONS ARE COMPRISED OF TOPICS FOCUSED ON ACCOUNTABILITY, ASSESSING POSSIBLE CONSEQUENCES OF ONE'S DECISIONS, ACTIONS PRIOR TO MAKING A DECISION, TAKING AN ACTION, CARING ABOUT IMPACT ON OTHERS AS OPPOSED TO BEING CONCERNED ONLY WITH SELF, AND OTHER RELATED ISSUES AND CONCERNS. PRIME FOR LIFE IS A PROGRAM IN WHICH STAFF MEMBERS ARE TRAINED AND CERTIFIED TO PROVIDE THIS EVIDENCE-BASED CURRICULUM FOCUSED ON PREVENTION AND TREATMENT WITH THOSE WHO HAVE BEEN REFERRED FOR ALCOHOL AND DRUG PROBLEMS. A MOTIVATIONAL RISK REDUCTION PROGRAM USED WITH PERSONS WHO HAVE HAD A LEGAL OR POLICY VIOLATION SUCH AS IMPAIRED DRIVING, POSSESSION, OR WORKPLACE VIOLATION, THAT HELPS FOSTER ATTITUDES, BELIEFS, AND UNDERSTANDING THAT REDUCES RISK FOR ANY TYPE OF ALCOHOL OR DRUG USAGE. IT INVOLVES 20 SESSIONS FOCUSED ON SELF-ASSESSMENT EXPERIENCE TO ENHANCE PERSON'S AWARENESS OF WHAT ONE VALUES, WHAT THE PERSON IS RISKING, AND HOW TO PROTECT THE THINGS THAT MEAN THE MOST IN THEIR LIVES. REFERRALS ARE RECEIVED FROM COMMUNITY CORRECTIONS. SAFE PLACE IS AN OUTREACH PROGRAM THAT EDUCATES YOUNG PEOPLE AND THE COMMUNITY ABOUT THE DANGERS OF RUNNING AWAY OR TRYING TO RESOLVE DIFFICULT, THREATENING SITUATIONS ON THEIR OWN. A FOCUS IS TO CREATE A NETWORK OF SAFE PLACE LOCATIONS TO PROVIDE SAFE HAVENS AND RESOURCES FOR YOUTH IN CRISIS. WITHIN THIS PROGRAM ARE SERVICES DIRECTED TOWARD THOSE WHO ARE VICTIMS OF HUMAN TRAFFICKING.
