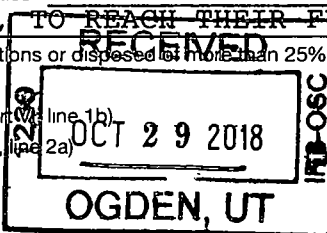

IN 2017, OUR MEMBERSHIP CONSISTED OF THE FOLLOWING: 42% WERE 6-9 YEARS OLD, 36% WERE 10-12 YEARS OLD AND 22% WERE 13-18 YEARS OLD. 52% WERE MALE, 48% FEMALE WITH 72% COMING FROM SINGLE PARENT OR FOSTER CARE HOMES AND 70% RECEIVING FREE OR REDUCED LUNCHES. 57% AFRICAN AMERICAN, 21% MULTI-RACIAL, 10% HISPANIC, AND 12% CAUCASIAN. 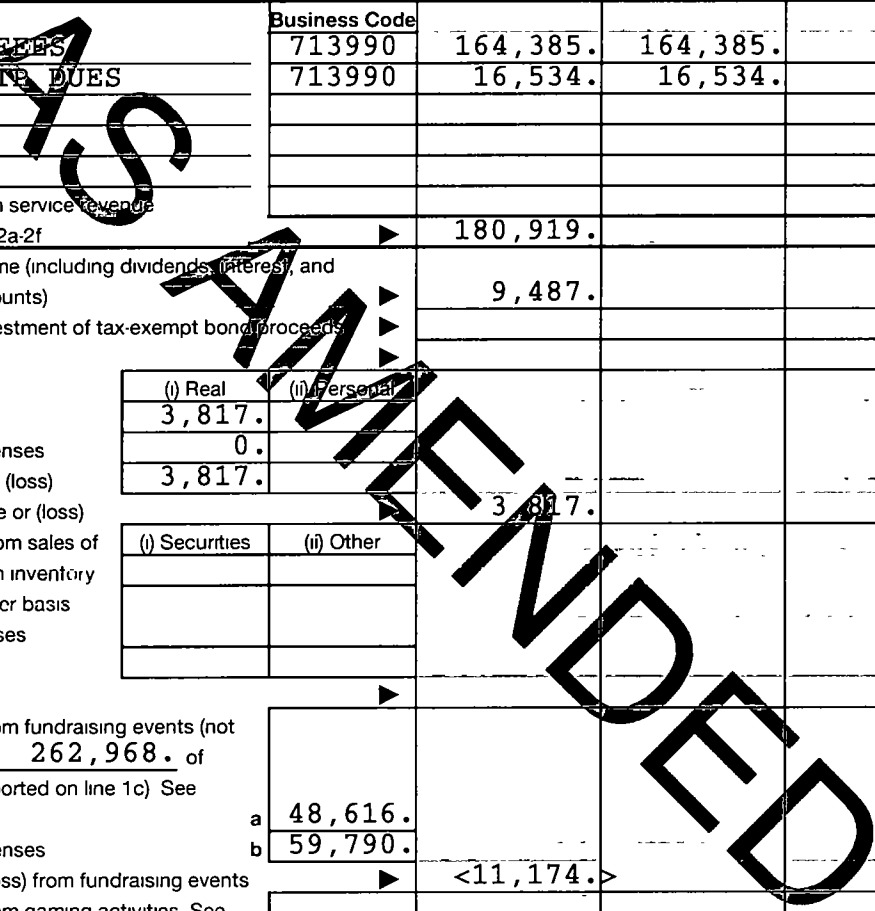

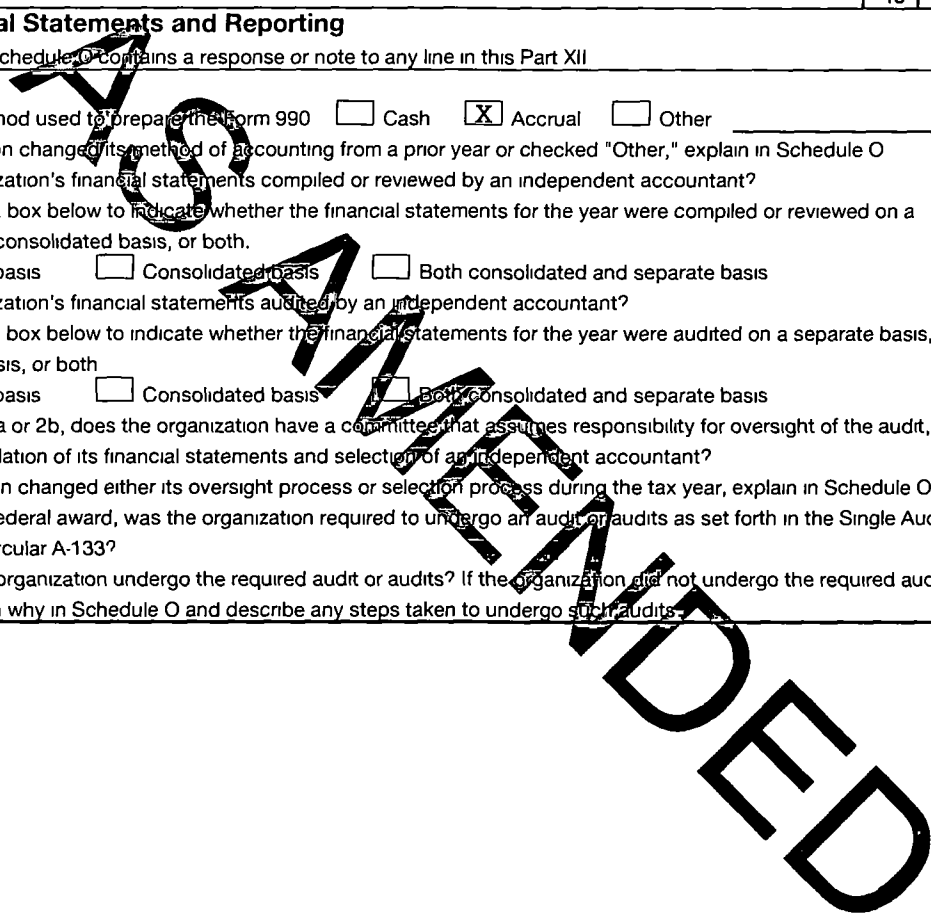
