Quality services are provided by our team of caring, respectful professionals who advocate for the patient. Care is provided to individuals without insurance on a "sliding fee scale," based on the individual's income and family size. Care is provided to the homeless free of charge. The organization provides care without charge or at amounts less than its established rates to patients meeting certain criteria under its charity care policy. Charity care is not reported as revenue.

ECHC provides dental healthcare to the general population of the Evansville, Indiana area. Services are offered to all payor and non-payor sources. Services are offered on a "sliding fee scale" for patients without insurance. Any patient who is deemed "homeless" is offered care at no charge per visit. Care is provided by dedicated and qualified clinicians, focusing on self care and health management. ECHC's provider staff include 3 dentist and 2 dental hygienist.
