The Gary Economic Development Corporation GEDC leads the City of Garys efforts to develop real estate, attract new businesses, expand and retain existing businesses, job creation, and increase the quality of life for City residents In 2015, GEDC continued its efforts towards the development of the University Park Neighborhood and Campus Plan, to redevelop a 7.5 square mile footprint surrounding Indiana University Northwest and Ivy Tech Community College It continued its relationship with Carmeuse Lime and Stone to invest 10M into a green technology facility, creating 100 construction jobs, and 30 - 40 full time positions once constructed GEDC also partnered with newly relocated Gary manufacturers T B Tube Co , a metal tubing manufacturer, and Edsal Manufacturing, a commercial grade shelving and storage system manufacturer, to create employment opportunities Lastly, GEDC partnered with Garmong Construction Services, an industrial shell construction company, to build industrial space in the Buffington Harbor area of Gary, for the purpose of attracting additional businesses
