The Landing's redevelopment will represent the most significant mixed use redevelopment of existing downtown property in decades. In 2016, Model Group, the developer, prepared architectural renderings of new construction and interior design. The Trust aided the developer to pursue funding available. By year end, most of the capital stack had been secured and a fully executed development agreement between the Trust, the City of Fort Wayne, and Model Group was near completion. The Trust anticipates financial closing in 4th quarter of 2017, with construction to follow soon after.
