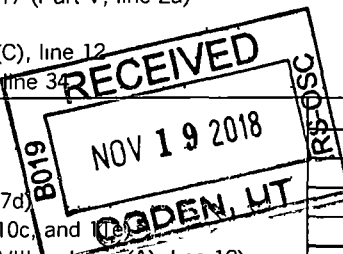

The Landing's redevelopment will represent the most significant mixed-use redevelopment of existing downtown property in decades. Model Group, the developer, closed December 21, 2017 on the real estate and conveyed title prior to the end of the year to The Landing I, LLC. The Trust financed \$460,000 of the purchase price to be paid by The Landing I at the time of closing on the financial package, which was anticipated by Spring 2018. The closing package was unanimously approved by the Board of Directors. Also, the Board unanimously approved the conveyance of the Smurfit property to the City Redevelopment Commission pursuant to the purchase agreement previously authorized, which will make possible a \$62 million mixed-use project, Hive, by Continental Property Group of Minnesota. The Trust was instrumental with demolition and site preparation for this project.
