In 2017, 253 homeless and at-risk of being homeless veterans and their dependents were provided services through this program, to include \$37,684 in financial aid provided. b Additionally under the Search and Rescue program, 2 large scale outreach events took place, our Annual Thanksgiving Meal Distribution Event and our 8th Annual Warm Full Safe Event. c During our Thanksgiving event we prepared and delivered 403 meals to homeless, transitionally housed, and low income veterans and their families throughout Brevard. d During the 8th Annual Warm Full Safe event, there were two primary components, our traditional event where we bring homeless veterans and their families into hotels Christmas Eve and Christmas day, providing warm meals, outdoor gear and clothes to them during their stay, and financial assistance provided to low income and at-risk veterans and their families, all of which were nominated by the community as needing assistance, throughout Brevard. In 2017 19 (7 from camps) homeless veterans and dependents were brought into the hotel in Titusville Florida. Additionally, \$22,207 was distributed in financial assistance to 92 households throughout Brevard County, impacting 175 total individuals, including 63 children of the veterans.
