For unsheltered clients our volunteers go out in to the streets and forests of our community to locate them, provide basic needs (food, outdoor gear, etc) to build rapport and help them address the immediate needs of homelessness, and then connect them with the VA, housing agencies, and benefits application specialists in order to get them housed rapidly and self-sustaining. For at-risk clients we need to stabilize their situation to prevent homelessness. We review their financial and legal situation, work with landlords to pause evictions, help them secure financial assistance needed to keep them in their homes, and work with pro bono attorneys to resolve legal issues that are preventing a stabilized life. In the first half of 2021, 148 homeless and at-risk of being homeless veteran families were provided services through this program, including \$14,356 in financial assistance for rent and utilities.
