The Executive Compensation Committee's recommendation is then approved at the next Executive Committee meeting. Article VIII of the Bylaws of the Association establishes the authority of the Executive Committee to act as the Board of Directors in the management of the Association. Comparability data is supplied by YUSA, as well as data supplied by Sullivan Center, executive compensation consultants (an independent compensation consultant). This data is used to compare the YMCA's officers and key employees salaries with like positions in the top 30 YMCAs (The North American Urban Group YMCAs). Additionally, the salaries are compared with like positions in both the for-profit general industry sector and the not-for-profit sector. Documentation of these decisions was kept by the YMCA's Executive Compensation Committee. This process was last undertaken in April of 2019 for the CEO & President and CFO.</p>
