THE CAMPS ARE DESIGNED FOR CHILDREN TO LEARN ABOUT THEMSELVES AND HOW TO GET ALONG WITH OTHERS, CARING AND SHARING IN AN ATMOSPHERE CONSISTENT WITH THE MISSION AND VISION OF THE YMCA. ON A WEEKLY BASIS, 134 CHILDREN ATTENDED A FUN-FILLED, WELL-SUPERVISED SUMMER AT YMCA DAY CAMP, IN 2022. AN EXCELLENT OPTION FOR WORKING PARENTS, MANY FAMILIES FIND THIS CHARACTER-BUILDING TIME IMPORTANT AND A CRITICAL SOURCE OF SUMMER CHILD CARE. APPROXIMATELY 10% OF THESE CAMP PARTICIPANTS WERE AWARDED FULL OR PARTIAL SCHOLARSHIPS TO COVER THE COST OF CAMP.
