Foster Care

Foster Care licenses and monitors foster homes and foster parents, and provides a loving, nurturing, and safe environment to children who have been removed from the custody of their biological parents due to child abuse or neglect. Foster Care provided 33,998 days of care to 127 children.

Groundwork

A domestic violence program for battered women and their children. Program provides emergency shelter, counseling, and social services. The shelter is open 365 days per year, 24 hours per day. We also provide advocacy to victims of domestic violence, to assist those seeking orders of protection or wishing to press criminal charges. Prevention education is offered in schools, businesses, and community organizations. During the year ended June 30, 2017, 12,554 days of shelter were provided to 251 people. 11,036.25 hours of counseling and advocacy were provided to 1,088 clients, and 472.5 hours of prevention education reached 5,817 people.

Sexual Assault Service Center

The Sexual Assault Service Center provides comprehensive services to adult victims of sexual assault and sexual abuse, their significant others, and the community. As of February 2000, children ages 3 and up also receive comprehensive services, including counseling. Direct client services include a 24-hour hotline, counseling, medical advocacy, case management, crisis intervention, and information and referral. The program also provides extensive educational services and offers trainings at schools, social service agencies, and community organizations. During the year ended June 30, 2017, clients received 3,409 hours of counseling and advocacy, and 44,245 people were reached through 1,968 hours of educational services.

The Board of Directors conducts an annual evaluation of the Chief Executive Officer. The CEO submits a self-assessment and the board members complete an evaluation checklist on the CEO.
