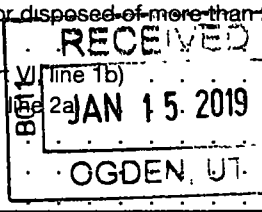

Foster Care
Foster Care licenses and monitors foster homes and foster parents, and provides a loving, nurturing, and safe environment to children who have been removed from the custody of their biological parents due to child abuse or neglect. Foster Care provided 33,712 days of care to foster children.

4b (Code:) (Expenses \$ **1,193,634** including grants of \$) (Revenue \$)
Groundwork
Groundwork is a domestic violence program for battered women and their children. The program provides emergency shelter, counseling, and social services. The shelter is open 365 days per year, 24 hours per day. Advocacy is provided to victims of domestic violence to assist in seeking orders of protection or wishing to file criminal charges against the perpetrator. Prevention education is offered in schools, businesses, and community organizations. During the year ended June 30, 2018 12,830 days of shelter were provided to 336 people. 11,598 hours of counseling and advocacy were provided to 2,059 clients, and 600.25 hours of prevention education reached 5,125 people.

Sexual Assault Service Center
The Sexual Assault Service Center provides comprehensive services to adult victims of sexual assault and sexual abuse, their significant others, and the community. As of February 2000, children ages 3 and over also receive comprehensive services, including counseling. Direct client services include a 24-hour hotline, counseling, medical advocacy, case management, crisis intervention, and information and referral. The program also provides extensive educational services and offers trainings at schools, social services agencies, and community organizations. During the year ended June 30, 2018, clients received 3719 hours of counseling and advocacy, and 47,853 people were reached through 2,070 hours of educational services.

When the next board meeting is held, the board votes on approval of Form 990. Upon approval, the Form 990 is signed by the Board Chairperson, and filed with the IRS.

All board members sign a Conflict of Interest statement when joining the board. Board members are required to update this statement annually. The board determines if a conflict exists.
