The Cradle accepts any baby referred to its care, whether healthy or medically fragile, and all placements are guided by a philosophy of open adoption. Care in The Cradle Nursery is provided free of charge, affording birth parents considering adoption greater peace of mind and eliminating worry about insurance coverage limits.
