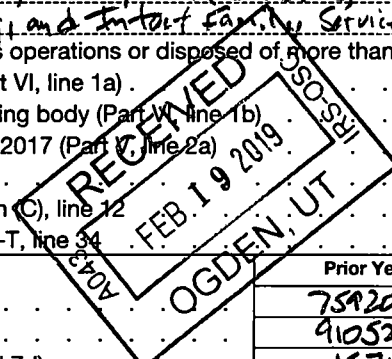

Families having founded incidents of abuse or neglect receive intensive services structured to correct the cause of abuse or neglect, while the children remain in the home. These in-home services last up to 6 months, in DuPage County, Illinois.

Pregnancy Support Services:
During FY 2018, 76 women and their families were served during their pregnancies. Care includes housing assistance, referrals for medical care, professional counseling, and supplies for basic needs. Services are provided free of charge during, and up to 6 months following pregnancy.

Our largest program Intact Family Services, seeks to assist local families that have experienced some level of abuse/neglect, and the Illinois Dept of Children & Family Services has mandated a basic level of service to prevent the children from being removed from the family of origin. The reporting entity manages the coordination of a variety of services to family members to address the problems that have brought the attention of authorities. This generally includes some level of counseling for mental health or chemical dependency issues. The reporting entity, pays the contracted therapists for sessions performed and in some cases funds are not provided directly to any client. If housing or transportation assistance is needed, the reporting entity pays the landlord, taxi service, etc., not the client. Only services actually provided are funded.
