These in-home services last up to 6 months, in DuPage County, Illinois.

Pregnancy Support Services:

Our largest program, Intact Family Services, seeks to assist local families that have experienced some level of abuse or neglect, and the Illinois Dept of Children and Family Services has mandated a basic level of intervention to prevent removing the children from the family of origin.

The reporting entity manages the coordination of a variety of services to family members to address the problems that have brought them to the attention of authorities. This generally includes some level of counseling for mental health or chemical dependency issues. The reporting entity pays contracted therapists for sessions provided and invoiced.

Funds are not provided directly to any client. If housing or transportation assistance is needed, the reporting entity pays the landlord, taxi/ride service, etc., and not the client. Only services actually performed are funded.
