This form has each position listed by title, labor grade, and the four (4) quartiles illustrating the spread of salary designated for each position. Also taken into consideration, for comparison purposes is salary survey information for highly compensation positions within the private not-for-profit behavioral healthcare providers in Illinois. This survey in the past has been conducted by Mass and Associates of Illinois. As for the other Alliance positions, the CEO performs those reviews and makes those salary determinations. Those compensation decisions and determinations have generally followed the same percentage increases given to the CEO on an annual basis.</p>
