LIKEWISE, THE BENCHMARK IS THEN ESTABLISHED FOR THE POSITION OF CHIEF OPERATING OFFICER AND CHIEF FINANCIAL OFFICER AND COMPENSATION IS ADJUSTED AS WARRANTED BOTH BY MARKET AND PERFORMANCE.
