### **Form 990, Part III, Line 4a:**

In FY 2018, CIC approved 75 loans for a total of \$61.8 million under the Multifamily Loan Program. These loans financed the acquisition and rehab of 1,658 residential and commercial units. All loans carried a 10-year term and most loans had a 25-year amortization. Of these units, 99% were affordable at 80% of area median income, 92% of the units were affordable at 60% of area median income, and 68% of the units were affordable at 50% of area median income. Beginning in April 2017, CIC began using Flex Fund second mortgages to fund energy savers loans in order to more fully integrate energy savers lending into the CIC multifamily platform. In total, at the close of FY 2018, CIC's Multifamily Loan Program Portfolio stands at \$196.8 million of notes sold to investors.

---

**Form 990, Part III, Line 4b:**

In FY 2018, CIC approved 20 loans for \$12.5 million for single-family rental properties totaling 249 units, a 47% year-over-year increase in loan volume. Over the four years of the 1-4 unit loan program, CIC has approved 67 loans for \$31.7 million totaling 574 residential units.

### **Form 990, Part III, Line 4c:**

In FY 2018, CIC and The Preservation Compact secured \$36.5 million to create the Opportunity Investment Fund (OIF), an innovative, streamlined vehicle to finance multifamily rental buildings and create affordable housing in high cost neighborhoods. OIF will provide existing, functioning multifamily rental buildings with low-cost mezzanine debt. In return, owner will keep 20% of their units affordable for 15 years. Both non-profit and for-profit owners will be able to use OIF. Owners may choose to use Housing Choice Vouchers or other types of operating subsidy to help offset reduced rents for the affordable units. In FY 2018, CIC approved \$781,000 in mezzanine debt for 6 OIF pilot loans. The loans were for buildings with a total of 112 units of mixed-income housing, of which 26 units are affordable to households at 50% AMI.
