Explanation: I was unable to adhere to our organization's process for filing taxes on time due to personal issues and pandemic related concerns. Additionally, I misinterpreted the date for filing an extension. The organization had to discontinue providing counseling services in person and implement alternative service delivery channels in order to meet the counseling needs which increases significantly over prior years. Our organization has only one paid employee position and all of this year's activities put us behind operationally. However, our current operating model is sound and should not impact future filing requirements.
