PREVENTION - FOR OVER 40 YEARS, 360 YOUTH SERVICES HAS BEEN A LEADER IN SUBSTANCE USE PREVENTION EDUCATION. ALL PROGRAMS CONTINUED TO BE IMPACTED BY THE PANDEMIC AND RELATED SAFETY PROTOCOLS, AND ADJUSTMENTS MADE TO PROVIDE SERVICES VIRTUALLY AND DIGITALLY CONTINUED WITH SUCCESS. NAPERVILLE OPERATION SNOWBALL FOCUSES ON YOUTH LEADERSHIP DEVELOPMENT TO EMPOWER HIGH SCHOOL STUDENTS. IN FY2021, 113 ATTENDED THE IMPACTFUL FALL AND SPRING VIRTUAL MULTIPLE DAY EVENTS AND 37 ATTENDED A WINTER VIRTUAL EVENING SINGLE SESSION EVENT.
