REASONABLE CAUSE EXPLANATION FOR LATE FILING OF Federal Form 990

1. The return was originally due December 15, 2020. Due to Covid -19; the Agency's operations were severely impacted. The offices were forced to close for a limited amount of time. When the offices reopened; many of the staff worked remotely. The hybrid work schedules created difficulty in performing administrative and accounting duties consistently. Gathering accounting documents and entering in the accounting system was delayed and severely backlogged.
2. The Agency was not able to file on time due to the above stated impact of Covid-19 on its operations and the difficulty of engaging an accounting firm to perform the audit.

Accounting Firms were also impacted by Covid-19 resulting in staff shortages. Due to staff shortages and lingering Covid-19 operational impact, were not able to engage an Accounting Firm until July 29, 2021. The audit was completed November 1, 2021.

The Agency engaged an accounting firm to then complete the preparation of the Federal 990 and Form AG990-IL.

We respectfully request waiver of any late filing fees and penalties.
