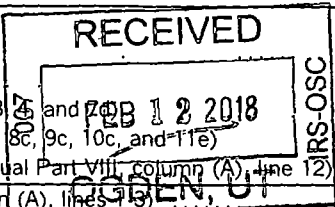

During FY 2017, CMAA is proud to have been selected into a capacity building program called Building High Impact Nonprofits of Color, a collaboration between Washington, D.C. based Prosperity Now and Georgetown University, in a year long program funded by JP Morgan Chase. CMAA's Executive Director, Dennis Mondero, and CMAA Youth Manager, Margaret Smith, personally participated in the program that selected five high-performing non-profit organizations in each of Chicago and Baltimore.

Participating organizations received comprehensive training and consulting from Georgetown University faculty and other consultants on best practices in a variety of areas, including non-profit board governance, service delivery, social impact evaluation, and fundraising. CMAA selected as its capstone project to further develop its system for measuring social impact, and with the aid of Georgetown Professor Beatriz Boccalandro, now has a wide range of national performance standards it can measure its internal departments on.

and various Managed Care Organizations (including Blue Cross Blue Shield, Aetna Better Health, and Meridian to name a few), CMAA offers in-home services for eligible seniors and clients with a physical disability in Cook, DuPage, and Kane Counties. CMAA is also licensed by IDPH to provide in-home services to private pay elderly clients. Our homemaker team is bilingual in multiple languages such as Cantonese, Mandarin, Vietnamese, Tagalog, Burmese, Laotian, Bosnian, and others. We provide in-home services such as assistance with medical visits and outings, bathing and grooming, walking and transfers, meal preparation, grocery shopping, housekeeping and laundry, and much more. In fiscal year 2017, CMAA was proud to serve almost 400 seniors and employed over 180 homemakers. With the addition of another full-time staff at CMAA's Elgin office, CMAA was able to more than double the number of our suburban clients out in DuPage and Kane Counties in 3 months! Additionally, CMAA's in-home services department manager serves on the Illinois Department on Aging CCP Advisory Committee, working very closely with the Department on Aging to help guide the department with their policy making decisions as well as advocate on behalf of CCP providers.

In addition, CMAA is proud to report that FY 2017 marked the first full year of its Elgin, Illinois operations. CMAA partnered up with the Lao Organization of Elgin to start its senior in-home services program, servicing Kane and DuPage Counties through the Elgin location. The office has begun to attract a good number of clients, as CMAA recognizes that so many immigrants and refugees in need of services actually live in suburban areas.

dancing, singing, and calligraphy. Each year, CMAA hosts a grandparent's luncheon in June and a mid-autumn festival luncheon in September for our members. In fiscal year 2017, CMAA's Golden Age Club had 150 active members. CMAA also endeavors to teach our immigrant seniors the importance of becoming more civically involved, and routinely brings groups of seniors to Chicago's City Hall and to the Illinois State Capitol.

Education, Employment, Citizenship:

Adult Education:

Through a grant from the Illinois Community College Board, CMAA and its partner agencies- the largest and most diverse consortium in the State of Illinois- offered ESL and Civics classes to over 1,000 immigrants and refugees across the City of Chicago in FY17. Partners included such diverse agencies as Arab American Action Network, Ethiopian Community Association of Chicago, Indo-American Center, Korean American Community Services, and Muslim Women Resource Center, among others. Our adult education classes helped prepare students to participate fully in their communities, and covered such topics as: the rights of immigrants and U.S. citizens, U.S. history and governance, accessing community resources, consumer economics, and workforce readiness skills. With the support of United Way of Metropolitan Chicago, CMAA's Adult Education program also offered Financial Literacy workshops in English, Vietnamese, and Mandarin languages. Instructors and guest speakers from Cathay Bank and International Bank of Chicago offered clients a comprehensive overview of the U.S. banking system, assisted clients in opening savings accounts, taught the importance of building credit, and provided tips for preventing identity theft.

CMAA staff counselors provided individualized employment preparation, referrals, and placement assistance to unemployed or underemployed community members. Our clients represent diverse professional backgrounds, such as healthcare, hospitality, and industrial work, and have various levels of education. Although CMAA primarily serves immigrants and refugees, our Workforce Development Program also attracts native-born Americans who resided in Uptown and took advantage of the services available, including job readiness training, resume writing workshops, and digital literacy support. In calendar year 2017, we served 220 unique clients; our reputation as a provider of quality, hardworking employees has helped create a network of employers, such as Weiss Memorial Hospital, O'Hare International Airport, and Peninsula Hotel, who regularly contacted CMAA for staffing needs.

Citizenship:

Since 1997, CMAA has offered citizenship and immigration legal services to low-income immigrants and refugees seeking to apply for U.S. citizenship and other benefits. Our Department of Justice (DOJ) accredited staff offered individualized legal counsel and case assistance at a low cost to clients and, often, in their native languages of Vietnamese, Cantonese, or Mandarin. In FY17, CMAA assisted over 360 clients apply for citizenship and prepare for the naturalization exam, and over 180 clients reunite with their families abroad, obtain green cards, apply for work authorization, or seek counsel for other immigration-related issues.

Throughout the year, CMAA worked closely with the Chicago Board of Elections to organize early voting and non-partisan voter education events ahead of elections, providing interpretation in a variety of languages. On November 1, 2016 CMAA turned out 103 community members to vote early in the presidential election. For many of

Social Services:

CMAA's social services department works with the Illinois Department of Human Services (IDHS) to break down language and cultural barriers to help low-income clients and families identify and access benefits that are available to them through local, state and federal programs. In fiscal year 2017, our direct service staff assisted over 600 clients and their families in applying for All Kids, SNAP, Medicaid, TANF and other public benefits. In addition, staff helped 1,237 low-income families and individuals apply for energy assistance to offset winter heating and summer cooling costs through the low-income heat and energy assistance program (LIHEAP). Furthermore, our housing services assisted clients with finding affordable and subsidized housing, providing assistance in understanding leases and foreclosures, and helping resolve tenant-landlord conflict. Staff also provided violent crime victim clients with information, resources, and referrals.

Youth Department:

CMAA's youth department serves youth from pre-school through young adulthood, and specializes in serving immigrant and minority youth. Our youth clients, most of whom are children of low-income immigrant and refugee parents, often face many challenges in their academic, social, and emotional development. CMAA's youth programs work to bridge that gap in a culturally empathetic way, providing responsible after school programming, young adult mentoring programs, and more.

CMAA's after school program serves youth from K to 8th grade and meets weekdays from 3-6 p.m. Each term (fall/winter and winter/spring) the program enrolls between 70-80 students, and in fiscal year 2017, the program enrolled approximately 92 unduplicated youth (7% of which were Chicago Housing Authority youth residents). Approximately 98% of participants were youth of color, and over 90% of youth (FY17) were from low to extremely-low income household. There is no required fee for CMAA's after school program, thus ensuring that CMAA is truly providing affordable, responsible after school care.

CMAA's after school program specifically focuses on homework help. A majority of the parents who enroll their children in our after school program have limited English language abilities and oftentimes, work in service industry jobs that require evening and weekend work. These parents look to CMAA's after school program to ensure youth are staying on track and meeting their academic goals. All students spend at least one hour on homework and additional studies, with staff and volunteers assisting youth participants. To assist students that need extra assistance, CMAA recruits volunteers from local universities in the Chicagoland area. CMAA's youth department currently has partnerships with DePaul University and both undergraduate and graduate programs at Loyola University.

CMAA promotes social and emotional development, the after school program also provides extracurricular activities for students. Our "Speaker Series" recruits ethnically diverse professional speakers such as doctors, lawyers, IT consultants, and artists to speak with our youth about their careers and life. CMAA is also one of the few agencies that has programming to teach youth cultural dances from their countries of origin. Youth are also allowed daily recreation time to be on

computers or play in the park, weather permitting.

When school is not in session, CMAA runs a popular summer camp program, which meets weekdays for all of July and August from 9 a.m. to 4 p.m. Summer camp programming enhances school time education, and youth take courses in science, math, reading, and writing, as well as participate in arts and crafts.. Life skills workshops in health, nutrition, and financial literacy are also offered, and students are encouraged to explore the city through field trips to the Shedd Aquarium and Lincoln Park Zoo. In fiscal year 2017, CMAA enrolled approximately 78 students (12% of which were CHA youth residents) in its summer camp program, with an average daily attendance of 50 students per day. Over 97% of students in CMAA's summer camp come from low to extremely-low income households, and over 85% were youth of color.

CMAA also offers young adult mentoring programs, and our young women's mentoring group, Young Women Warriors (YWW), has been a prominent community service for more than 15 years. YWW is a free, year-round mentorship program that brings young women ages 11 to 18 together with older female mentors that are successful leaders and role models in their community. A youth-led mentoring program, YWW mentors and mentees meet twice a month for a variety of workshops and activities, including applying for college, financial literacy, female health, rock climbing, kayaking, and more. YWW works to guide young women of color as they navigate high school, college, and beyond, and in FY2017, YWW served 19 girls in college, high school and middle school. Approximately 90% of our mentees are from families that live at or near the poverty line, and nearly 95% of participants are young women of color.

In FY17, CMAA's youth department launched the agency's first social enterprise

initiative, Tiger Tutor. An ACT and SAT test prep program, Tiger Tutor focuses on individualized, high quality instruction. The program is dedicated to helping students achieve their academic and collegiate goals and works closely with both students and provide unique study plans and curricula. In FY17, Tiger Tutor received a grant from the Chicago Community Trust, covering a portion of the endeavor's start-up costs for our first two years of operation. Tiger Tutor helps students reach their individual test prep goals while successfully helping CMAA diverse its revenue streams, ensuring our agency is able to continue to provide vital social services to our community.
