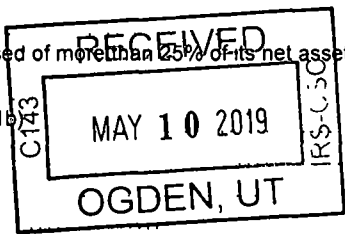

During the period of July 1, 2017 to June 30, 2018, LACM served approximately 4,735 Lao community members in its core programs. Key agency accomplishments included:

"Walk-in Services: 2,041 Lao community members (mostly Lao elders) with limited English proficiency received assistance with translating documents, applying for benefits, consumer advocacy and much more. In addition, 110 people were offered refugee and immigration services by a multi-lingual volunteer. LACM continued to host a Hennepin County Multicultural unit Lao-speaking advocate who assisted 115 walk-in service clients.

Key outcomes included 17 different engagement sessions with Minneapolis departmental leaders and Lao community members in Warroad, 398 voter registrations, 550 voter pledges and 500 people participated in voter education.
