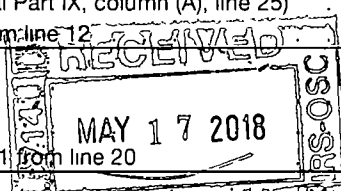

Our programs are utilized to strengthen families by modeling positive parenting techniques, providing a safe environment for court ordered supervised visitation, and providing education on child abuse, stress management, anger management, and budgeting for low income families.

This program uses evidenced-based strategies to help families develop parenting skills, learn positive discipline techniques, and identify and implement stress management techniques. Through this program children are given an opportunity to grow up in an abuse free, loving and safe environment. In 2017: 100 families were served through this program; 4,887 hours of service provided. Staff and volunteers were utilized for this service. (130 adults and 251 children) 88% of families saw a decrease in the number of Child Protection reports. 92% of families developed and utilized Positive Parenting Skills and Discipline Techniques 92% of families developed and utilized Stress Management Skills 86% of families that are no longer receiving services completed the Parent Mentor Curriculum and are familiar with the Search Institute's 40 Developmental Assets for Youth

4b (Code: 624190) (Expenses \$ 73,608 including grants of \$ 0) (Revenue \$ 124,773) SUPERVISED VISIT PROGRAM. Dodge, Steele, Rice Waseca (LeSueur, Olmsted, Mower-outside of service area) served in 2017. This is a fee-based program that supervises visits between children and parents. Our goal is to ensure that parents required to have supervised visitation can continue to build a relationship with their child during the reunification process. In 2017: 62 families were served with this program. 1,884 hours of supervision were provided Contract labor utilized for this service. (65 adults and 158 children)
