MCHENRY AND CRYSTAL LAKE TRANSITIONAL SHELTERS: THIS PROGRAM PROVIDES TEMPORARY SHELTER AND SUPPORTIVE SERVICES FOR 97 HOMELESS WOMEN, AGE 18 AND OVER. THE WOMEN ARE SINGLE, SOME ARE PREGNANT, AND SOME ARE ACCOMPANIED BY THEIR CHILDREN. WHILE IN THE SHELTER, CLIENTS' IMMEDIATE PHYSICAL AND MENTAL HEALTH NEEDS ARE ADDRESSED FIRST. FAMILIES SHARE A ROOM, EACH INDIVIDUAL WITH THEIR OWN BED, IN A SAFE ENVIRONMENT. CASE MANAGERS AND COUNSELORS PROVIDE COMPLEX TRAUMA INTERVENTIONS, AND COLLABORATE WITH OTHER AGENCIES TO PROVIDE CLIENTS WITH THE BEST POSSIBLE SERVICES AND RESOURCES. CLIENTS ARE OFFERED TRAININGS IN LIFE AND JOB SKILLS, FINANCIAL MANAGEMENT, NUTRITION, AND PARENTING. CASE MANAGERS IDENTIFY RESIDENTS' JOB READINESS SKILLS AND WORK TO FILL GAPS OR BARRIERS. CHILDCARE IS ARRANGED WHILE WOMEN

THE AFFORDABLE HOUSING PROGRAM: HOME OF THE SPARROW, INC. HAS 19 UNITS OF AFFORDABLE HOUSING FOR LOW TO MODERATE INCOME FAMILIES WHO WERE HOMELESS, OR AT RISK OF BECOMING HOMELESS, WHICH PROVIDED HOUSING FOR 67 CLIENTS. THESE HOUSING UNITS ARE FOR WOMEN AND THEIR CHILDREN WHO HAVE AN ANNUAL INCOME OF 50 PERCENT OR LESS OF THE AREA MEDIAN INCOME, OFFERING A SAFE, COMFORTABLE PLACE TO LIVE.
