MCHENRY TRANSITIONAL SHELTERS: EACH YEAR, THIS PROGRAM PROVIDES TEMPORARY SHELTER AND SUPPORTIVE SERVICES FOR APPROXIMATELY 100 - 110 INDIVIDUALS: WOMEN AGES 18 AND OVER, AND THEIR CHILDREN. THE WOMEN ARE SINGLE, SOME HAVE CHILDREN, AND SOME ARE PREGNANT. THE SHELTER INCLUDES NINE DORM ROOMS THAT ACCOMMODATE SINGLES AND FAMILIES; THE DORM ROOMS SHARE TWO KITCHENS, BATHROOMS, AND LAUNDRY FACILITIES.
