SUBSIDIZED APARTMENT PROGRAM ("SAP") (FORMERLY TRANSITIONAL APARTMENT PROGRAM): THIS PROGRAM PROVIDES A VITAL BRIDGE BETWEEN THE TRANSITIONAL SHELTER AND PERMANENT HOUSING WITHIN THE COMMUNITY. SOME CLIENTS ARE READY TO MOVE INTO COMMUNITY LIVING BUT REQUIRE EXTRA TIME TO BUILD RESOURCES NEEDED FOR INDEPENDENT LIVING. SAP OFFERS THREE UNITS OF SUBSIDIZED HOUSING FOR CLIENTS WHO HAVE A JOB BUT CANNOT AFFORD TO PAY AFFORDABLE HOUSING PROGRAM RENT. WHILE IN SAP, CLIENTS CONTINUE TO RECEIVE ALL THE SERVICES OFFERED IN THE SHELTER PROGRAM. MANY OF THESE CLIENTS NEED TO PAY OFF UTILITY ARREARS AND REPAIR CREDIT HISTORY BEFORE THEY BECOME ELIGIBLE TO SIGN A RENTAL CONTRACT FOR HOUSING IN THE COMMUNITY. THIS PROGRAM OFFERS AN ESSENTIAL STEP BETWEEN SHELTER LIVING AND MOVING INTO COMMUNITY INTEGRATED AFFORDABLE HOUSING. SAP CLIENTS GENERALLY STAY IN THE PROGRAM FOR A YEAR BEFORE MOVING INTO THE ORGANIZATION'S AFFORDABLE HOUSING PROGRAM OR INTO OTHER HOUSING WITHIN THE COMMUNITY.
