The LCCAC provided an interagency coordinated response, referred to as MDT, for children under the age of 18 when there has been an allegation of sexual abuse, physical abuse or a child has witnessed a major crime. The MDT representatives (Law Enforcement, DCFS, Advocates, Medical, Mental Health, Lake County States Attorneys Office) contribute their knowledge, experience, and expertise for a coordinated, comprehensive, compassionate and professional response to ensure the child's safety. In 2020, the LCCAC served approximately 840 children. Not included in the above expenses are contributed services paid directly by the Lake County State's Attorney Office (LCSAO) in the amount of \$815,154, which is net of \$65,556 reimbursed by the Organization. Grants from the Illinois Criminal Information Authority and the Illinois Department of Children and Family Services of \$216,791 and \$60,285, respectively, were paid to the LCSAO for salaries, benefits and occupancy costs. The County of Lake also provided office space, at no cost, with an estimated value of \$48,000 and total materials donation of \$43,061. Contributed services and materials for the fiscal year totaled \$906,215 (\$815,154 + \$48,000 + \$43,061).
