THE NORTHEAST ENTREPRENEUR FUND HAS ONE PROGRAM AND THAT IS TO PROVIDE PROFESSIONAL DEVELOPMENT TO BUSINESS OWNERS IN THE SERVICE AREA AND PROVIDE LOANS TO SUPPORT THE BUSINESSES. IN 2016, TOTAL PROGRAM COSTS OF \$1,924,295 WAS EXPENSED TO PROVIDE SERVICES TO 566 PARTICIPANTS AND OF THOSE PARTICIPANTS 127 LOANS WERE DISBURSED TO START, STABILIZE OR EXPAND THEIR BUSINESSES. A TOTAL OF 61 JOBS WERE IMPACTED DUE TO THE SERVICE PROVIDED ALONG WITH \$5,539,195 IN LOANS WERE APPROVED OF WHICH 50% WERE LOW TO MODERATE INCOME BUSINESS OWNERS AND WERE NOT BANKABLE. THE ORGANIZATIONAL EXPENSES, NON-PROGRAM RELATED WERE A TOTAL OF \$403,298 FOR FUNDRAISING, MANAGEMENT AND GENERAL COSTS TO SUPPORT THE MISSION AND FUTURE OF THE ORGANIZATION
