 Stewardship of Community Assets Property Management manages and maintains the assets so that low to moderate income families' have homes that they can be proud of Property Management manages the leasing and occupancy of TRP's commercial and residential properties, including building maintenance, everyday operations, tenant support services, security, community involvement, and financial management and strategic planning for the division Property Management increases the value and performance of all TRP residential and commercial properties by combining high quality property management with successful tenant relationships In addition to overseeing the physical, financial, and tenant management of all its properties (340 units of affordable rental housing in 33 different buildings), TRP strives to sustain affordability while enhancing the residences' social atmospheres to support a healthy living environment for all tenants
