The Organization operates a food pantry located on its premises that serves the needs of the greater Chicago Southland community by distributing a wide variety of food items along with personal care products. For the year ended June 30, 2017, the Organization provided food assistance to 47,529 individuals.

The Organization bridges the gap for Chicago Southland residents in temporary crisis by providing emergency payments for rent, mortgage and utilities so that the Organization's clients can remain in their homes. For the year ended June 30, 2017, the Organization provided homeless prevention services to 607 individuals.

The Organization participates in the U.S. Department of Housing and Urban Development's Family First program providing both housing and guidance in learning basic life skills to homeless parents.
