The organization aims to help survivors of gender violence achieve safety, stability and self-sufficiency, and to provide community education and advocacy in an effort to positively impact systems, and improve overall conditions for the survivors we serve. Apna Ghar developed its own model of holistic service delivery in collaboration with Loyola University's Center for Urban Research and Learning based on an ecological framework that takes individual, family, community as well as systemic and societal barriers into account.
