With ICE's assistance, the Coalition has worked since 2004 to develop a new model for delivering community mental health services tailored to local community needs for poor and vulnerable local residents. Through the Coalition's efforts The Kedzie Center opened as the first new Expanded Mental Health Services clinic in October 2014 and provides services free of charge to residents seeking care in the Albany Park, Irving Park, North Park and Forest Glen communities.

HOUSING BRONZEVILLE:

With ICE's assistance, Bronzeville residents have worked during the past 11 years to convince Chicago's leaders to develop a pioneering program of affordable homeownership on their community's hundreds of city-owned vacant lots. As a result of ICE's efforts a development team is poised to build a first phase of new affordable homes on six such lots in the Washington Park community.
