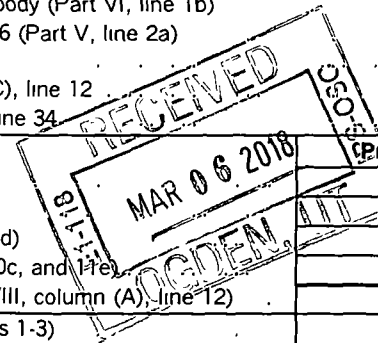

EXPANDED MENTAL HEALTH SERVICE PROGRAMS:

Working in partnership with the Coalition to Save Our Mental Health Centers, ICE helped educate and support residents in the North Lawndale, East Garfield Park, West Garfield Park, and Near West Side communities as they established a new West Side Expanded Mental Health Services Program through a binding community referendum supported by 37,824 residents on November 8, 2016. ICE proceeded to work in 2017 with North Lawndale residents to conduct interviews with key community leaders, police officers, youth workers, and service providers as part of the pioneering West Side Community Mental Health Needs Assessment that established a framework for the community's new mental health center.

AFFORDABLE HOMEOWNERSHIP DEVELOPMENT:

Working in partnership with the Lugenia Burns Hope Center, ICE met with a development team and city officials to seek to finalize plans for a first phase of Bronzeville Affordable Homes in the Washington Park community, as advocated by local residents through their work for a decade with Housing Bronzeville.

CITIZEN NOW PROGRAMS:

ICE initiated and facilitated six cycles of its 12-week, 24-session, afterschool Citizens Now Program (CNP) for fifth, sixth, and seventh graders at Dvorak School of Excellence, Chalmers School of Excellence, Depriest Elementary School, and Penn Elementary School in the North Lawndale and Austin communities. Fifty-five students successful completed the CNP and then presented what they learned at Take Action Days
