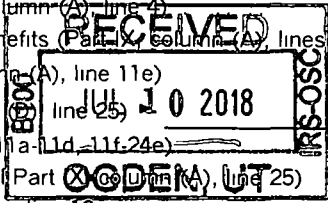

ICE initiated and facilitated six cycles of its 12-week, 24-session, afterschool Citizens Now Program (CNP) for fifth, sixth, and seventh graders at Dvorak School of Excellence, Chalmers School of Excellence, Depriest Elementary School, and Penn Elementary School in the North Lawndale and Austin communities. Fifty-five students successful completed the CNP and then presented what they learned at Take Action Days that they organized and led.
