Working in partnership with the Coalition to Save Our Mental Health Centers, the Institute for Community Empowerment (ICE) attended monthly meetings of the Governing Commission of the West Side Expanded Mental Health Services Program and made recommendations on best practices. Its interns and staff helped residents in the Logan Square, Avondale, and Hermosa communities initiate and conduct a petition collective drive resulting in 8,800 signatures to place a binding community referendum on the November 6, 2018 ballot.

AFFORDABLE HOMEOWNERSHIP DEVELOPMENT:

Working in partnership with the Lugenia Burns Hope Center, ICE initiated monthly meetings of Housing Bronzeville at the Oakwood Shores Community Center to educate residents about opportunities for affordable homeownership in the Bronzeville community. It attended three general meetings of residents of Oakwood Shores where it provided educational information as well. It also met regularly with a development team and city officials to seek to finalize plans for a first phase of Bronzeville Affordable Homes in the Washington Park community.

CITIZEN NOW PROGRAMS:

ICE initiated and facilitated four cycles of its 12-week, 24-session, afterschool Citizens Now Program (CNP) for fifth, sixth, and seventh graders at Dvorak School of Excellence, Chalmers School of Excellence, Johnson Elementary School, and Penn Elementary School in the North Lawndale community. 75 students attended classes and
