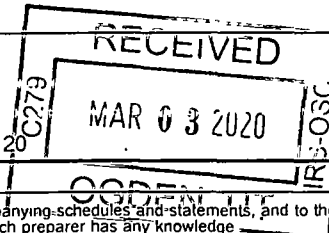

Working in partnership with the Coalition to Save Our Mental Health Centers, the Institute for Community Empowerment (ICE) attended monthly meetings of the Governing Commission of the West Side Expanded Mental Health Services Program and made recommendations on best practices. It also laid the groundwork for future campaigns to fund and support residents' efforts in additional Chicago communities to create their own new mental centers.

AFFORDABLE HOMEOWNERSHIP DEVELOPMENT:

Working in partnership with the Lugenia Burns Hope Center, ICE initiated monthly meetings of Housing Bronzeville at the Oakwood Shores Community Center to educate residents about opportunities for affordable homeownership in the Bronzeville community. It continued to meet regularly with a development team and city officials to seek to finalize plans for a first phase of Bronzeville Affordable Homes in the Washington Park community.

CITIZEN NOW PROGRAMS:

ICE initiated and facilitated two cycles of its 12-week, 24-session, afterschool Citizens Now Program (CNP) for fifth, sixth, seventh, and eighth graders at Dvorak School of Excellence and Oscar Depriest Elementary School. 45 students attended classes and 25 students successfully completed the CNP and graduated. Students planned and organized two sessions with guest speakers, one a musician and the other
