**EXPANDED MENTAL HEALTH SERVICE PROGRAMS:**

Working in partnership with the Coalition to Save Our Mental Health Centers, the Institute for Community Empowerment (ICE) led a team of youth advocates to lay the groundwork for a Bronzeville Expanded Mental Health Services Program (EMHSP), starting on June 10, 2020 and educating 1,750 residents by June 30 about the possibilities of creating a new Program. It advised Community Action Teams, Governing Commissions, and/or service providers of three existing EMHSPs in North River, Logan Square/Avondale/Hermosa, and the West Side on steps to strengthen local resident involvement and utilize best practices with model Commission documents. The North River EMHSP at The Kedzie Center had 3,733 clinical encounters with 413 clients and collaterals during this fiscal year. ICE also initiated a funding campaign to enable residents to create new EMHSPs and mental health services in additional communities throughout Chicago.

**AFFORDABLE HOMEOWNERSHIP DEVELOPMENT:**

Working in partnership with the Lugenia Burns Hope Center, ICE worked with Housing Bronzeville to hold monthly meetings at the Oakwood Shores Community Center to educate residents about opportunities for affordable homeownership in the Bronzeville community. It continued to meet regularly with a development team at the Hope Center to finalize plans for a first phase of Bronzeville Affordable Homes in the Washington Park community.
