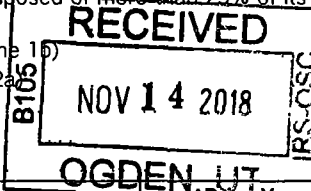

Muslim Run:

The Muslim Run Corner Store Campaign addresses the long history of injurious business practices, ingrained racial tensions, and unhealthy food options that typifies many inner-city corner stores. Since its launch, the Campaign has focused on four critical goals:

Developing alternative business models for corner stores on Chicago's South Side.
Using public policy to promote lasting change toward food justice.

Launching an education campaign that stresses the benefits of healthier lifestyles.

Healing racial tensions between Muslim and/or Arab store owners and their mostly Black patrons.

In January 2016, the Inner-City Muslim Action Network (IMAN) expanded to the Atlanta metro area. This effort is the result of several years of working closely with leaders in Atlanta and successfully training local community organizers. Directly serving "returning citizens", IMAN Atlanta's Green ReEntry program offers a holistic regiment including transitional housing, spiritual development, basic education, life skills instruction, on-the-job construction training, and job placement support.

Arts and Culture

IMAN has incorporated art and cultural expression as an integral aspect of its programming since the inception of the organization over ten years ago. Celebrating

traditional Muslim art forms while actively engaging contemporary expressions of popular culture has lent a dynamic edge to IMAN's art and culture programming that has generated local, national, and international media coverage on Muslims in the arts. Moreover, IMAN's role in such programming has served to empower and connect young Muslims and others with a vibrant means to connect to one another and the larger society.

For more than a decade, high school students, community organizers, public officials and religious leaders from all walks of life have worked towards building Chicago's very first memorial honoring Dr. Martin Luther King, Jr., to be located at the site of his historic 1966 Marquette Park March. The Martin Luther King, Jr. Living Memorial Project commemorates the 50th anniversary of that historic August 5th event. Recalling the larger legacy of the March - and remembering the struggle for justice, equity and dignity - is more urgent now than ever in our city, across our nation and around the world. This memorial was completed in 2016.
